- A \$60.00 deposit is required on each costume ordered. The deposits are due on or before October 31, 2022. Balances for costumes will be due on or before February 1, 2023.
- Please keep billing up to date to insure your child receives costumes. We cannot distribute costumes to any student who has an outstanding balance on either tuition or costumes.
- If your child will not be participating in our annual dance recital a written statement is needed by October 31, 2023. After this date there will be no costume refunds.
- If your child starts dance later in the year a \$10.00 shipping and handling fee will be added.
- Costume deposits will be added to your billing statements in October.
- Costume balances will be added to your billing statement in January.
- Parents are responsible for any alterations needed. Most costume companies will only distribute so many of each size costume to dance studios. Costume distribution will be finalized by the teachers and we will do our best to insure your child has a proper fit.
- There is no refund on costumes.
